INSTRUCTIONS FOR COMPLETING VETERINARY SERVICES (VS) FORM 17-129 (APPLICATION FOR IMPORT OR IN TRANSIT PERMIT)

***For faster and easier application submission and review by our office, please utilize our online system, <u>APHIS eFile</u>, to create and submit your application. If you are not completing the application in APHIS eFile, please fill out the PDF 17-129 application as instructed below".

Before you fill out your VS Form 17-129

There is a processing fee for each application submitted; current fees can be found here. Payment is required before an application can be processed. Payment can be made by check or money order made out to USDA, APHIS; credit cards (VISA, MasterCard, American Express, or Discover Card); or through a user fee account established with the Agency. A delay in payment will cause a delay in processing.

Complete boxes 1 through 14: Additional instructions are provided for the following:

In Box 5: Under the first column, list the number of animals. If a shipment is semen or embryos, indicate the number of doses, ampules, units or straws. For hatching eggs, please include number of eggs. Also, for bovine semen and embryos indicate if they are conventional, sexed or both.

In Box 5E: Purpose of Importation -- indicate if shipment is an importation or transit. **Note**: For animals transiting the United States by air to a third country, stops at U.S. airports may generally be made for crew change and refueling only.

Unloading of animals during transits may be permitted under certain conditions approved in advance by APHIS. (Please contact the Strategy and Policy - Import Animals at the following phone number: 301-851-3300 or email: LAIPermits@usda.gov for information regarding any transits where animals may need to be unloaded.)

Transiting animals, semen, embryos, or hatching eggs are subject to supervision by VS port personnel. VS port personnel must be given at least 72 hours prior notice of exact time and date of arrival. For animals that are imported and intended for entry into the United States, please contact the <u>individual quarantine facilities</u> regarding any required quarantines for imported animals.

In Box 6: Make sure to include the name of ship/airline and the vessel/flight number. List "TBD" if unknown at this time.

In Box 7 & Box 8: Permits for semen, embryos and most species of live animals are valid for 14 days from the proposed arrival date (30 days for fish, birds, poultry and hatching eggs). Please be as accurate as possible in listing proposed shipping and entry dates.

In Box 12: Please include an email address. Applications will not be processed without an email address. Applicants should list their payment method (bank card information or

a user fee account with the agency) and any additional information you wish to send. For bovine semen, please list the sexing facility approved address.

Submitting VS Form 17-129

If completing VS Form 17-129 manually, email the signed, completed application and payment information to <u>LAIPermits@usda.gov</u>.

Receiving Permits

After receipt, permit applications will be reviewed. If all requirements for importation are met, a VS form 17-135 Permit to Import Animals, Semen or Embryos will be issued. Standard processing time is a minimum of 7 business days.

No animals, animal semen, animal mal semen, animal embryos, birds, poultry, or hatching eggs will be imported unless a completed application has been received (9 CFR Part 92 and 9 CFR Part 93).

According to the Paperwork Reduction Act of 1995, an agency may not conduct or sponsor, and a person is not required to respond to, a collection of information unless it displays a valid OMB control number.
